

**PreSentence Investigation Report**  
**CONDITIONS OF PROBATION**

1. Probationer shall lead a law-abiding life.
2. Probationer shall remain within the jurisdiction of the Court unless granted permission to leave by the Court or the Probation Department.
3. Probationer shall truthfully answer all reasonable questions by the Probation Officer and notify the Probation Officer prior to any change in address or employment.
4. Probationer shall report to a Probation Officer as directed and permit the Probation Department to visit probationer at his/her residence or elsewhere.
5. Probationer shall notify Probation Officer within 24 hours if arrested or questioned by any law enforcement officials.
6. Probationer shall submit to warrantless search of person, property, residence or vehicle upon the request of the Probation Department. Probationer shall acknowledge and agree that any law enforcement officer may assist the Probation Department in this search.
7. Probationer shall sign any release of information consent forms necessary to allow the complete exchange of information between the Probation Department and any treatment provider(s).
8. Probationer shall pay all fines, surcharges and other Court fees as directed by the Court.
9. Probationer shall refrain from the use, possession or sale of alcohol or any mood-altering drugs unless prescribed by a physician and taken in the prescribed dosage.
10. Probationer shall refrain from frequenting any establishment, gathering or place where alcohol is sold or served for on premise consumption.
11. Probationer shall avoid places where illegal drugs are used, possessed or sold.
12. Probationer shall submit to any recognized testing to determine the use of alcohol/drugs. The Erie County Probation Department is directed to collect a one-time Drug Testing Fee of \$50.00, if applicable. Payment of the Drug Testing Fee shall not constitute nor be imposed as a condition of a sentence of probation.
13. Probationer shall submit to a drug/alcohol evaluation as directed by the Probation Department and shall comply with all treatment recommendations, including inpatient and/or outpatient.
14. Probationer shall abide by a curfew of 9 p.m. to 6 a.m. unless otherwise directed by the Probation Department.
15. Probationer shall have no contact with any individual(s) on probation or parole or any individual(s) designated by the Probation Department.
16. Probationer shall not associate with individuals involved in illegal activities and shall avoid all places where illegal activities occur.

### CONDITIONS OF PROBATION

17. Probationer shall secure and maintain verifiable employment, as approved by Probation, upon successful completion of an educational or vocational training program.
18. Probationer shall submit to a mental health evaluation as directed by the Probation Department and shall follow all treatment recommendations.
19. Probationer shall take all medications as prescribed by physicians and mental health care providers.
20. Probationer shall cooperate with any counseling recommended by the Probation Department, including inpatient, if necessary and remain in such program until successfully discharged.
21. Probationer shall avoid contact with the victim and shall abide by all Orders of Protection and/or any other Court-imposed Order. Probationer shall provide the Probation Department with a copy of any such Order within seven (7) days of its receipt.
22. Probationer must notify the Probation Officer within 24 hours of contact with any parties protected by an Order of Protection.
23. Probationer shall pay restitution to the victim, along with a 10% surcharge, through the Probation Department in an amount and according to a schedule determined by the Court.
24. Probationer shall maintain a residence approved by the Probation Department and secure the Probation Department's approval prior to any change in residency.
25. If not granted Youthful Offender status, the probationer shall provide a DNA sample pursuant to New York State Executive Law Section 995 and shall pay a \$50.00 fee for such a procedure.
